<p><b>Trade Data Subscriptions</b></p> <p>Trade data subscriptions consist of municipal securities transaction reports submitted by brokers, dealers and municipal securities dealers (“dealers”) to MSRB’s Real-time Transaction Reporting System. These subscriptions are available in real-time, bulk and historical timeframes as shown below:</p>
